### About NTT Finance UK Limited

NTT Finance UK Limited is a wholly owned subsidiary of NTT Finance Corporation. NTT Finance Corporation is part of the NTT Group, a leading, global technology services company headquartered in Tokyo. NTT Finance UK Limited's main mission is to procure fund through various funding sources, and provide comprehensive financial support to promote the advancement of NTT Group businesses mainly in Europe. NTT Finance UK Limited has GBP 3,500,000 capital, and as at the date of this statement, five directors and two assistant managers.

### Our Values and Commitments

At NTT Finance UK Limited, we are fully committed to attaining the highest standards of ethical conduct and integrity in all our business activities, including preventing slavery and human trafficking throughout our organisation and in our supply chain.

### Our Policies on Modern Slavery and Human Trafficking

NTT Finance UK Limited expects all our employees to work in accordance with business values and principles outlined in " Purpose, Vision, Values " and other internal policies and training resources. "Purpose, Vision, Values" was established on 6 November 2023 because this era of significant change has promoted us to redefine our corporate purpose and mission and to operate our business under shared values to ensure our ongoing contribution to society (<https://www.ntt-finance.co.jp/eng/company/purpose/index.html>). " Purpose, Vision, Values" and all other applicable policies are readily available to all NTT Finance UK Limited employees on our Intranet.

NTT Finance UK Limited has adopted the following NTT Group policies for identifying and seeking to prevent modern slavery and human trafficking in its operations and supply chains:

- **NTT Group Global Sustainability Charter:** This sets out the responsibility to respect all human rights, including those of our customers, stakeholders, and our entire business value chain.

- **NTT Group Human Rights Policy:** This sets out our commitment to respect and protect human rights, in accordance with UN Universal Declaration of Human Rights and with the UN Guiding Principles on Business and Human Rights. The Global Human Rights Policy prohibits all forms of forced and compulsory labour, human trafficking, and child labour, and highlights our commitment to correct or eradicate labour practices that violate human rights.

- **NTT Group Corporate Ethics Policy:** The aim is to encourage openness and we ask our employees, and third parties, to report any knowledge or suspicion of slavery or human trafficking using the "Corporate Ethics Helpline". NTT Finance UK Limited operates a strict non retaliation policy and will not, in any way, retaliate against a whistleblower acting in good faith.

- **Procurement Policies:** This seeks to realize a sustainable society by doing procurement with an emphasis on human rights, the environment, safety, and other critical issues, in compliance with laws and social norms.

- **NTT Group Guidelines for Sustainability in Supply Chain:** The NTT Group has published the "NTT Group Guidelines for Sustainability in Supply Chain" to promote initiatives aimed at achieving a sustainable society in the supply chain. The NTT Group also conducts supplier engagement activities to ensure that all suppliers in the supply chain comply with this guideline. This guideline prohibits forced labor, child labor and regulates working hours.

In the establishment of the above policies, NTT Corporation has engaged with its group companies to create a shared understanding in prevention of modern slavery and human trafficking.

## Our Supply Chain

NTT Finance UK Limited's main service is to procure funds through various funding sources (such as commercial paper and bank loans from financial institutions not only in UK or Japan but also in other countries such as US), and provide comprehensive intra-group financial support for NTT Group companies, either directly or through its parent company NTT Finance Corporation, to promote the advancement of NTT Group businesses mainly in Europe.

Our supply chains provide us with goods and services. NTT Finance UK Limited strives to

ensure that our supply chains operate in an honest, fair, and transparent manner. Together with our suppliers, we are acting and striving to address various social issues related to human rights, labour, environment, and corrupt practices that may occur within our supply chain. All suppliers, sub-contractors, and business partners we engage must agree to our position on human rights and commit to not using any form of forced labour. They must comply with the NTT Group Guidelines for Sustainability in Supply Chain, all applicable modern slavery laws and regulations, and have adequate controls in place to ensure that they are not exposed to or complicit in human trafficking and modern slavery. To date, we have not been made aware of, through our "Corporate Ethics Helpline" or otherwise, any complaints or allegations of human trafficking or slavery activities against any of our suppliers. Should NTT Finance UK Limited become aware of an incident of modern slavery or human trafficking within its supply chain, NTT Finance UK Limited will work with the relevant supplier to implement swift remedial actions.

### **Risk assessment and Management**

NTT Finance UK Limited recognizes the challenges around modern slavery in complex global supply chains, and we are fully committed to understanding and minimizing the risks of modern slavery associated with goods and services we purchase. As at the date of this statement, Takahisa Onishi, Director of NTT Finance UK Limited, is in charge of understanding and minimising such risks.

NTT Finance UK Limited has a zero-tolerance approach to modern slavery and human trafficking, and all forms of corruption and bribery associated with these criminal acts. We are committed to acting ethically and with integrity in all our business relationships and to implementing and enforcing effective systems and adequate controls aimed at preventing any form of modern slavery within our business and our supply chain.

As a financial company, our ongoing assessment indicates that the risk of modern slavery or human trafficking occurring within our business is low, when compared to other industries. We are committed to continuously improving our risk assessment process to ensure we are in a position to timely identify and remediate any modern slavery concerns that could be connected to both our business and supply chain.

Our objective is to operate an effective supply chain governance framework which minimizes the risk of slavery and human trafficking within our supply chains. NTT Finance UK Limited will ensure that we do not knowingly participate in any activity that involves any form of

modern slavery or enter into business with any organisation which knowingly supports or is found to be involved in slavery, forced or compulsory labour, or human trafficking.

NTT Finance UK Limited also incorporated the terms requiring compliance with all applicable laws, rules and regulations including those related to modern slavery and human trafficking in our standard contracts. We would regard any confirmed instance of modern slavery or human trafficking as a breach of contract and reserve the right to take appropriate action, including the ability to terminate such contracts immediately.

NTT Finance UK Limited consults with lawyers from time to time to catch up revisions of the Modern Slavery Act (if any).

### **Training and Awareness**

We have implemented mandatory employees online training on sustainability, harassment, corporate ethics and human rights awareness to raise awareness on human rights and compliance every year. Furthermore, NTT Finance UK Limited engages with its employees through the "Purpose, Vision, Values" of NTT Finance Corporation. The "Purpose, Vision, Values" states employees to follow integrity, high ethical standards and build trust with customers.

NTT Finance UK Limited aims at continuously conducting business by complying to NTT Group Human Rights and Supply Chain Guideline with zero cases of human rights violation, including modern slavery and human trafficking.
