About official documents for identification

When making a request related to personal information, you are required to attach one of the following official documents for identification.

- A copy of your driver's license (within the period of validity, and issued by a local public safety committee. An International Driving permit is not acceptable. Please attach the back side, if it contains the current address.)
- A copy of your passport (within the period of validity, together with the page containing your face photo and address)
- A copy of your health insurance card (without the insurance identification code and number) and either a resident's card (without individual number or permanent address) or a utilities receipt or bill
- Copy of your eligibility verification certificate (within the period of validity, your insurance identification code and number must be masked) and either of the following that displays your current address: (i) an original copy of your resident record (*juminhyo*) (that does not display your individual number ("My Number") or permanent address; if your individual number or permanent address is displayed, such information must be masked); or (ii) a utility rates receipt or bill
- A copy of your alien registration card (within the period of validity, and allowing NTT FINANCE to confirm your current address.) and either a copy of your passport or a utilities receipt or bill.
